

**United Healthcare - Unique In-Network Provider ID # = MPIN**

**What is an MPIN?**

1. An MPIN is a unique provider ID number that UHC assigns each provider when loaded into their internal network database. The acronym stands for "Market Provider Identification Number".
2. Unfortunately, when an old provider record is terminated in UHC's system, they do not always clean up/remove those unnecessary records, This in turn causes operational confusion in the Prior Authorization process, Customer service patient benefit and eligibility confirmation calls, claims payments, etc.
3. The attached list contains all of our unique provider MPIN for our direct UHC contract. This includes all branches accross all entitis (NSM, Hudson & HME).

**Why is it important to have this MPIN listing at our fingertips?**

1. Payer Relations receives consistent alerts from the Funding teams or other field contacts advising us that "UHC has stated that we are Out Of Network in X state..."
2. All Funding Specialists should all have this as a tool to ensure that our in-network provider records are located when contacting UHC for Prior Authorization submission, patient benefit confirmations and for claim processing purposes.
3. Please provide the appropriate state level MPIN to the UHC clinical case manager or customer service representative at the beginning of your call.
4. Providing the "MPIN" number at the time of call will assist UHC in locating our ACTIVE in-network provider record and clear any confusion/remove room for error for UHC to provide us with an older out of network terminated WCP record, old NSM record, etc.
5. As additional branches are added, such as Jackson, MS eff. 9/15 we will refresh the document on WNSM.
