SUMMARY ANNUAL REPORT FOR NATIONAL SEATING & MOBILITY, INC. 401(K) PLAN

This is a summary of the annual report Form 5500 Annual Return/Report of Employee Benefit Plan of National Seating & Mobility, Inc. 401(k) Plan and Employer Identification Number 62-1400785/Plan Number 001 for the plan year 01/01/2023 through 12/31/2023. The Form 5500 annual report has been filed with the Employee Benefits Security Administration, as required under the Employee Retirement Income Security Act of 1974 (ERISA). Your plan is a single employer, defined contribution plan with the following characteristics: profit sharing, ERISA section 404(c), total participant-directed account, code section 401(k) feature, code section 401(m) arrangement, 401(k) or 403(b) plan that provides for automatic enrollment, total or partial participant-directed account, pre-approved pension, member of a controlled group.

Basic Financial Statement

Benefits under the plan are provided by insurance contracts and a trust fund. Plan expenses were \$6,126,036. These expenses included \$273,638 in administrative expenses and \$5,732,960 in benefits paid to participants and beneficiaries, and \$119,438 in other expenses. A total of 2649 persons were participants in or beneficiaries of the plan at the end of the plan year, although not all of these persons had yet earned the right to receive benefits.

The value of plan assets, after subtracting liabilities of the plan, was \$76,808,165 as of the end of the plan year, compared to \$61,495,995 as of the beginning of the plan year. During the plan year the plan experienced a change in its net assets of \$15,312,170. This change includes unrealized appreciation or depreciation in the value of plan assets; that is, the difference between the value of the plan's assets at the end of the year and the value of the assets at the beginning of the year or the cost of assets acquired during the year. The plan had total income of \$21,438,206, including employer contributions of \$1,526,898, employee contributions of \$7,979,216, other contributions/other income of \$713,539, and earnings from investments of \$11,218,553.
